ELECTRONIC TOLL COLLECTION SYSTEM: HOW TO USE AND PAY TOLL

BelToll – is an electronic toll collection system which has been operating in Belarus since 1 July 2013. Payment is made with the help of the electronic payment device which must be installed in the vehicle.

The use of BelToll system is mandatory for the drivers of:

- ALL VEHICLES > 3.5 t.
- MOTOR VEHICLES ≤ 3.5 t REGISTERED OUTSIDE OF THE CUSTOMS UNION.

TARIFFS FOR THE USE OF TOLL ROADS*	
≤ 3.5 t – 0,04 €/km	> 3.5 t, 3 axles – 0,115 €/km
> 3.5 t, 2 axles – 0,09 €/km	> 3.5 t, 4 axles and more – 0,145 €/km

PAYMENT IS ACCEPTED ONLY IN BELARUSIAN RUBLES as per exchange rate set by the National Bank of the Republic of Belarus for the date of payment.

PLEASE PREPARE BELARUSIAN RUBLES IN ADVANCE! There is a currency exchange office at every border crossing point.

VIOLATION OF THE RULES OF TOLL ROAD USE CAUSES SERIOUS CONSEQUENCES – INCREASED TOLL.

The increased toll for one violation:

- ≤ 3.5 tons, if totally unpaid – 100 euro, if partially unpaid – 50 euro
- > 3.5 tons, if totally unpaid – 260 euro, if partially unpaid – 130 euro

*Approved by the Ministry of Transport and Communications of Belarus.

ON-BOARD UNIT

- Get the OBU (requires a deposit of 20 € for a vehicle ≤ 3.5 t, / 50 € for a vehicle > 3.5 t).
- Top-up the on-board unit.
- Set the correct number of axes including security fastened.
- Mount the OBU properly on the windscreen.

IN CASE OF TOWING VEHICLES subject to payment of tolls for use of toll roads:

- by tow bar or by flexible towing, install onboard units on each of the vehicles and indicate the number of axes on each of the onboard units in accordance with the design of each vehicle.
- by partial loading, install an onboard unit on the towing vehicle and indicate the number of axes equal to the total of axes of the towing vehicle and of the vehicle to be towed.

ATTENTION! It is obligatory to TAKE THE OBU ALONG TO A CUSTOMER SERVICE POINT to top-up the OBU account! One on-board unit is assigned to ONE LICENSE PLATE NUMBER ONLY!

DRIVERS SHOULD MAKE SURE THEIR ON-BOARD UNIT IS WORKING PROPERLY BEFORE ENTERING A TOLL SECTION OF THE ROAD, AS WELL AS PAY ATTENTION

POST-PAY USER CONTRACT

Only for vehicles with maximum laden weight of over 3.5 t.

Registration only via fleet card issuers: Belorusneft, Berlio, DKV, E100, euroShell, Eurowag, PEK "Belavtostrada".

Benefits:

- One contract for all vehicles in your fleet.
- No need to stop at Customer Service Points to top-up the OBU account.
- Payment for the OBU deposit and toll will be undertaken via the fleet card.

PRE-PAY USER CONTRACT

For all vehicle classes.

Registration at Customer Service Points.

- VISIT ANY CUSTOMER SERVICE POINT WITH THE FOLLOWING DOCUMENTS:
 - Registration certificate of a legal entity or an individual entrepreneur (original or copy) (not necessary for private persons).
 - ID of a person responsible for the registration.
 - Power of attorney to sign the agreement.
 - The vehicle registration document (original or copy) for legal entities and original vehicle registration document for private persons for every registered vehicles.
- PAY THE DEPOSIT AND TOP-UP THE ACCOUNT MINIMUM FOR 25 € ONLY IN BYR!
- IS YOUR WINDSCREEN METALLIZED OR SOLAR REFLECT? PLEASE ASK YOUR CAR MANUFACTURER ABOUT THE ON-BOARD UNIT MOUNTING LOCATION.
- CHECK YOUR DATA IN THE USER CONTRACT.

ATTENTION! It is obligatory to TAKE THE OBU ALONG TO A CUSTOMER SERVICE POINT to top-up the OBU account! One on-board unit is assigned to ONE LICENSE PLATE NUMBER ONLY!

TO THE OBU SIGNALS DURING THE WHOLE PERIOD OF THE TOLL ROAD USE. If there is more than one signal or there is no signal at all, do not take the toll road, contact call center infoline and go to customer service point immediately!

DRIVERS SHOULD MAKE SURE THEIR ON-BOARD UNIT IS WORKING PROPERLY BEFORE ENTERING A TOLL SECTION OF THE ROAD, AS WELL AS PAY ATTENTION
